### 4. Team Sports.

Each Team Organiser must complete the Team Entry Form and each Team Member must complete an individual Entry Form. All team entries need to be bulk posted.

### 5. Age Limit.

Competitors must turn the minimum age for the sport(s) to be competed in by 31<sup>st</sup> December 2019. The minimum age for competitors varies from sport to sport. Proof of age may be requested.
